LETTER FROM THE CHAIR

The Allen Foundation's support of nutritional therapy work in the South-central African nation of the Republic of Malawi over the last two years has resulted in improved measures of nutritional well-being for the county's children, including findings that refute the common belief that feeding HIV infected children is futile. The findings, made possible by a grant by the Allen Foundation, have recently been highlighted in newspapers, magazines and television reports.

The Allen Foundation Research Endowment Fund at Saginaw Valley State University will provide a base of financial support for faculty members in the College of Science, Engineering, and Technology, and in the College of Nursing and Allied Health. The endowment will be funded by a grant of \$1 million, consisting of an initial grant of \$500,000.00 and two additional grants scheduled for 2002 and 2003 of \$500,000.00. The fund will support research enabling the exploration of human nutrition issues and will facilitate further nutritional research by leveraging outside grants.

The foundation would like to be in a financial position to assist all grant requests, but its resources are unfortunately limited and in many cases have already been committed. Consequently, applications should never view possible declinations to fund proposals by the foundation as judgements on the actual merits of their proposals.

GRANT APPLICATION PROCEDURE

The Allen Foundation Inc. operates under the laws of the State of Michigan, with offices in Midland. In order to be considered for an Allen Foundation grant, you must be a non-profit organization, and be able to provide us with a copy of your federal Internal Revenue Service certification of 501(c)(3) tax-exempt status. Academic research under an Allen Foundation grant should be conducted under the leadership of a principal investigator who is a full-time regular faculty member with tenure or on tenure tract. The foundation does not directly administer the programs which it funds. Recipients are asked to submit yearly progress reports and a financial accounting concerning the expenditures of the foundation grant.

Grants are limited under the terms of the charter to projects that primarily benefit programs for human nutrition in the areas of health, education, training, and research. Application forms are available on request and must accompany all grant proposals.
